

# **FIRE UPDATE** Thursday September 24, 2020

8:00 AM

### TODAY

Progress continues to be made on containment as the Bobcat Fire is now 50%. One of the priorities today will be the northeastern corner of the fire from Highway 2 to Big Rock Creek Road where crews will be working to construct direct handline. If this is not feasible, they will prepare for strategic firing. The areas where strategic firing took place north of Mt. Wilson will continue to burn out today and if needed and conditions warrant aerial ignition will be used to increase the depth along Highway 2. In the northwestern section of the fire crews continue to construct direct handline from Highway 2 to Little Rock Reservoir. This is very steep and difficult country and It will take several days to accomplish this task. In Antelope Valley crews will continue to secure line and mop up around structures. The eastern and southern portions from Crystal Lake around to Mt. Wilson remain mop-up, monitor and patrol status. # YESTERDAY

Yesterday crews successfully held all of the previous day's strategic firing operations. Direct handlines were constructed around the spot fire at Barley Flat, and a new spot fire in this area was also lined. An indirect handline was completed north from Highway 2 to Big Rock Creek Road. Fire activity moderated overnight except in the Mt. Waterman vicinity.

# WEATHER

Today the weather will be similar to yesterday, with light winds and humidity in the teens. High pressure will move in on Friday, starting a significant warming and drying trend. There will be near record temperatures and very low humidity and on Saturday there will be the possibility of gusty northeast winds.

The Bobcat Fire started on September 6<sup>th</sup> at 12:21 PM. The fire is located near the Cogswell Dam and West Fork Day Use area. The fire is burning in heavy fuels with a rapid rate of spread.

The Forest Service has extended its temporary Regional Forest Closure Order to Sept. 24th. Forests included in this closure are: Angeles, Cleveland, Los Padres, San Bernardino, Inyo, Sequoia, Sierra, Klamath, and Six Rivers. The Forest is closed to all general activity, including developed campgrounds and day-use sites due to wildfire threat. Prohibition of the use of any ignition sources (campfires, gas stoves, etc.).
