- Sampling date: Los Angeles Basin sites were sampled 4/28/21 (La Tuna site burned over during La Tuna Incident in September 2017; Woolsey Site burned over during Woolsey Incident in November 2018), Santa Monica Mountains 4/29/21 (Clark Motorway site burned over during Woolsey Incident in November 2018), Santa Clarita Valley 4/26/21 (Peach Motorway site burned over during Calgrove Incident in June 2015; Placerita Canyon site burned over during Sand Incident in July 2016), and High Country sites 4/26/21 (Soledad Canyon site burned over during Sand Incident in July 2016).

### LIVE FUEL MOISTURE SUMMARY / FIRE DANGER ZONE DISCUSSION

Live Fuel Sampling is being reestablished at 4 Historic sites: Woolsey Canyon, Tanbark Flats, Templin Highway & Soledad Road. The addition of these sites will allow for the tracking of LFM in the High Country and Los Angeles Basin. The Santa Monica Mountains, Santa Clarita Valley and All Areas All Fuels Data sets and Graphs remain unchanged by these additions.

On average we are seeing Live Fuel Moisture values across all areas in Los Angeles County plateauing. Species sampled across the county continue with their shoot elongation with some species starting to produce flowers.
